To Members of the Working Group of Experts on People of African Descent,



My name is Amanda Wallace and I am the Founder of Operation Stop CPS. CPS stands for Child Protective Services, a corporation that is funded by the United States Government, a member of the United Nations. This corporation is an existential threat to the Black Family.

As I prepared to write this statement today, I researched the founding of the United Nations. It was founded after millions of lives had been lost after World War II and a group of people gained enough power to carve out a new way forward. Representatives from 50 countries gathered at the United Nations Conference on International Organization in San Francisco, California to draft and sign the UN Charter, which they hoped would prevent another world war. In reality, this history teaches us that the UN Charter may have prevented another world war, but it did nothing to stop the internal war waged against Africans enslaved in the U.S. by our colonizer, the U.S. Government.

The United States was one of the five principal powers at the conference. We must remember that the U.S. stole this power by raping, torturing, murdering and enslaving people of African Descent. Keeping that historical reference in mind, we begin to reimagine a way forward where African people have the power to neutralize the threat to our children. First we have to realize that it would be counterproductive for people of African descent to unite with Nations responsible for the enslavement and oppression of African people. The resolution would be flawed from the start.

The United States government as a whole, is the biggest threat to African people. Every system, still in existence, that was birthed from the minds of white supremacist, enforces the dreams of our captors. The Family Regulation System, known by many as the Child Protection System, is one of those dreams that have become a nightmare for millions of Black Families. Families are being ripped apart and parents rights are being terminated daily with little to no evidence of a law even being broken. Essentially, children are being kidnapped by the State in the form of modern day slavery and the courtroom has now become the New Auction Block in the sale of African children.

Our organization, Operation Stop CPS, was born out of the minds of liberated Africans that understood that there was an immediate need to build the power of the Black Family to defend their rights against the watchful eye of the government. As an ex-investigator for the Family Regulation System, I understand first hand that the system will never fix itself because it is operating how it was intended to operate.

As you listen to stories from families impacted by this system today, you can no longer say you are unaware of the immediate threat this system poses to African children. Even though the research has been clear for decades, we believe the collective voice of families impacted by the terror of this system will compel you to action. The Working Group of Experts on People of African descent must stand with Africans in the U.S. to neutralize this threat. Operation Stop CPS has a plan to abolish the Family Regulation System and we are calling on the United Nations to take the following action to expedite the execution of this plan:

- **Make a public statement acknowledging Child Protective Services as in fact, the Family Regulation System, and hold the U.S. accountable for the human rights violation committed against African people.**
- **Establish a formal review process for families seeking relief due to their rights being violated by the Family Regulation System and establish monetary compensation that shall be paid to families for each violation.**
- **Immediately appropriate funding to establish an Operation Stop CPS in every state to investigate cases of families seeking relief due to their human rights being violated by a member of the UN Charter.**
- **Work with African people currently occupying the United States, against our will, through the process of slavery, to establish our own seat at the table, separate from the representatives chosen by our colonizer, the United States of America, a member of the UN Charter.**

In closing, I want to again remember the history of the founding of the United Nations. It was a pivotal time in the New World Order. It brought organization to white power that, if untamed, would lead to its own demise. Instead, those in power realized that in order to make the white man feel safe enough to suppress his white supremacist ways, it had to create a system that made Africans a mode of production for white power. Knowing this history, Africans must convene and organize to develop our own way forward, separate from our captors.

We will do this; but the question I have for the members of the Working Group, is will you be an ally or stand in opposition? Keep in mind that your silence signals opposition to Africans ready to see the abolishment of this system.
