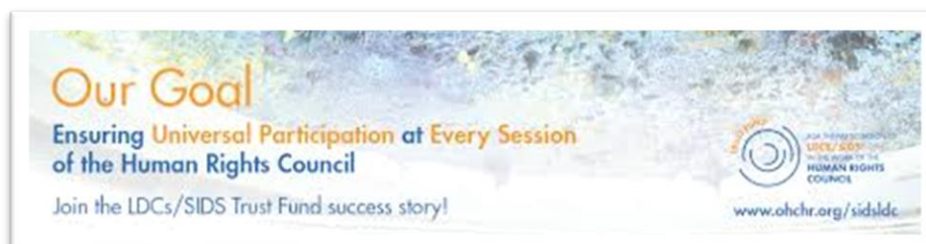

# Angola

**Head of the Department of Human Rights Protection and Monitoring,

Ms. Sílvia Joaquina do Nascimento Lunda is an official of the Ministry of Interior since 1999. As the Head of the Department of Human Rights at the Ministry of the Interior since 2018, Ms. Lunda organized, coordinated and facilitated training in human rights for officers that make up the Ministry of Interior, such as the Police, the Migration and Foreigners Service, Civil Protection Services, Criminal Investigation Services, Penitentiary Services, Border Guard Police, with a particular emphasis on promoting and protecting fundamental rights.

She also participated in the preparation and submission of State reports at the level of international and regional treaties, as a member of the Intersectoral Commission for the Elaboration of National Reports on Human Rights (CIERNDH). She is currently the mentor of the cooperation protocol between the Ministry of Interior and the United Nations Development Program (UNDP) on Human Rights and Law Enforcement, which aims to train human rights officers.

Ms. Lunda has a Bachelor's Degree in International Relations from Private University of Angola and has attended post-graduate courses on human rights at the Department of African Studies of Autonomous University of Madrid and on International Human Rights Law at the Human Rights Center of Oslo University Law School in Norway.

M. Omondélé Clauvis Ogoubiyi est un diplomate de carrière. Il a rejoint le Ministère en charge des Affaires étrangères de la République du Bénin en juin 2007 et y a servi jusqu'en 2011 à la Direction des Affaires juridiques, précisément au Service des Traités, où il a contribué à la ratification de plusieurs instruments juridiques internationaux, y compris dans le domaine de la promotion et de la protection des droits humains, et à la négociation de nombreux accords internationaux. Il y a acquis une solide expérience qui s'est affinée sur le plan théorique avec sa participation au séminaire de Droit international à Genève en juillet 2011 et au programme de perfectionnement des Nations Unies en Droit international à l'Académie de la Haye, du 30 juin au 8 août 2014. Monsieur Ogoubiyi a également servi à la Direction des Organisations internationales du Ministère des Affaires étrangères, où il a dirigé le service des Nations Unies de 2012 à 2014, ainsi qu'à l'Ambassade du Bénin à Kinshasa, de 2015 à 2019. Depuis son retour à la Centrale en 2019, il contribue aux performances de la Direction des Affaires juridiques d'abord au poste de Chef du service de la codification des lois et règlements puis à celui de Directeur adjoint, à compter de

février 2021. A ce poste, il coordonne les activités de tous les services de la Direction, notamment celui des droits humains, et participe au suivi de la mise en œuvre des instruments juridiques tant universels que régionaux en la matière.

Mme. Juliette Bambara Ouedraogo est Conseiller en droits humains au Ministère de la Justice et des Droits humains, chargé des Relations avec les Institutions. De 2015 à décembre 2017, elle a été chargée de la promotion des droits de l'homme à travers la réalisation d'activités de renforcement de capacités tels que les formations, les sensibilisations et la vulgarisation de documents et textes juridiques sur les droits de l'Homme à l'endroit notamment des forces de défense et de sécurité, des membres des organisations de la société civile et des leaders communautaires. Elle a assuré également l'appui conseil et l'orientation de victimes de violation des droits humains vers des structures compétentes.

Depuis 2018, Mme. Bambara est Chef de Service de l'éducation formelle aux droits humains. Elle est chargée du suivi et la coordination des actions de mise en œuvre du processus de l'éducation aux droits humains, conformément au programme mondial en faveur de l'éducation aux droits humains adopté par résolution 59/113B de l'Assemblée générale, du 14 juillet 2005. A cet effet, elle mène des plaidoyers auprès des acteurs éducatifs pour l'effectivité de l'enseignement des droits de l'homme dans les systèmes d'éducation primaire, secondaire et supérieur de son pays. Elle a participé à l'élaboration d'un Plan d'action national de mise en œuvre de l'éducation aux droits humains au Burkina Faso (2020-2024), dont elle assure actuellement le pilotage et la coordination.

# Cambodia

Presently, Mr. Sothy is a Deputy Chief of Bureau in the Human Rights Office, Department of the United Nations of the Ministry of Foreign Affairs and International Cooperation of Cambodia. This position allows him to directly support and coordinate with the Permanent Mission of Cambodia to the United Nations Office at Geneva. Furthermore, he works on the preparation of studies, research and reports pertaining to human rights in collaboration with the competent authorities in Cambodia. He authors aide-memoires and talking points about human rights and democracy for the leaders. Mr. Sothy has served with the Ministry of Foreign Affairs and International Cooperation of Cambodia since 2020.

Before that, Mr. Sothy had opportunities to spend nearly five years working with international human rights organizations to serve Cambodian and foreign government officials and partner non-governmental organizations to end slavery, to rescue and to restore Cambodian victims of trafficking. He worked to strengthen justice system and to bring criminals to justice.

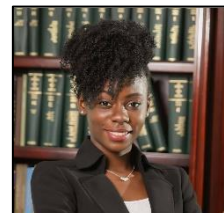

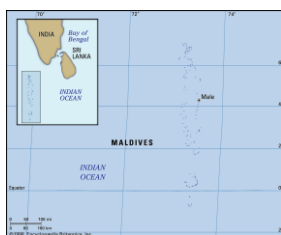
Ms. Nomena Andriamifidy is a career diplomat who joined the Ministry of Foreign Affairs of Madagascar in 2017, working first in the Consular and Legal Affairs Department (2017-2018) and since 2018 in the Department of Multilateral Relations. She is in charge of the analysis and study of international events related to human rights violations, to International Humanitarian Law as well as the decisions taken within the different international judicial bodies. She provides technical advice to the higher authorities in determining positions of Madagascar in relation to human rights situations and questions on the international scene. Her department is also in charge of the coordination of Madagascar's relations with international organizations specialized in

humanitarian and social affairs. At a national level, as the head of the human rights section she represents the Ministry in all the national committees and institutions related to the protection and the promotion of the human rights in Madagascar, as well as the implementation of international instruments ratified by Madagascar. She is the focal point of the Ministry in all the national committees in charge of human rights and social affairs: gender focal point, deputy focal point in the national office for the fight against human trafficking and, most importantly, member of the national committee in charge of drafting Madagascar's national reports on human rights and the preparation of Madagascar's UPR reports as well as periodic reports to United Nations treaty bodies on the implementation of international instruments to which Madagascar is a party.

## Maldives

Mr. Adam Hamid is a career diplomat who joined the Ministry of Foreign Affairs in March 2010. Since then he has been promoted through the ranks, currently holding the position of Head of Human Rights Division at the Multilateral Department of the Ministry. He is entrusted with overseeing the Human Rights Division, which includes engaging with the Human Rights Council and providing policy directives and forging closer ties with multilateral institutions, facilitating communications and engagements between line ministries and relevant international organizations, as well as engagement with non-governmental organizations.

Mr. Adam is a member of the national committee for the monitoring of the implementation of international instruments to which Maldives is a party in the field of human rights. As such he plays an instrumental role in compilation of several state party reports to United Nations treaty bodies and mechanisms including the UPR, ICCPR, CERD, ICESCR, CRC and CAT among others. He also represented Maldives in various international meetings, forums and conferences such as the third cycle of the Maldives Universal Periodic Review held in Geneva in 2020, and sixth periodic report of Maldives considered by the Committee on Elimination of Discrimination against Women at its 80<sup>th</sup> session held in Geneva in 2021. He also represented the Maldives in the 5<sup>th</sup> China Foreign Ministry Consultation, 1<sup>st</sup> and 2<sup>nd</sup> Japan-Maldives Policy Dialogue and 5<sup>th</sup> Maldives-India Joint Commission in 2015.

Mr. Adam completed his posting as the First Secretary / Chargé d'affaires at the Embassy of Maldives in Japan from 2016 to 2019. During this period, he coordinated Maldives-Japan bilateral relations.

Mr. Adam completed his degree in BA (Hons) Business Management at the Segi University in Malaysia in 2008 and Master of Public Policy, Specialized in International Relations, Political Economy, Trade and Industrial Policy at the Korean Development Institute in 2015.
