Recommendation:

many purposes regarded by legal fiction as already born.

Abortion is quite contrary to India's sound tradition

- Article 14 of "Hindu Law" considers a child in its mother's womb as a person equal in all respects to a child already born (except for the purposes of adoption).
- Article 14 of the Constitution of India says "The state shall not deny to any person equality before the Law or the equal protection of Laws within the territory of India."
- Article 21 of the Constitution of India says "No person shall be deprived of his life or personal liberty according to the procedure established by Law". 5

Abortion is an abominable crime against God who is the only Life-Giver, against the Nation and against all the innocent human beings who are being killed in our mother's wombs today. It is a publically known and terrible fact that every year six million of innocent Indian citizens are being killed by abortion.

Conclusion
