Nevertheless, we are fully aware that much remains to be done and I can assure you that Romanian authorities shall never cease their efforts in accomplishing the highest attainable standards in the field of human rights protection.

For the immediate future, our action shall concentrate on implementing the existing legislative framework, completing the reform of the judicial system, fighting corruption, eradicating poverty and continuing the social integration of vulnerable groups, especially Roma ethnics.
