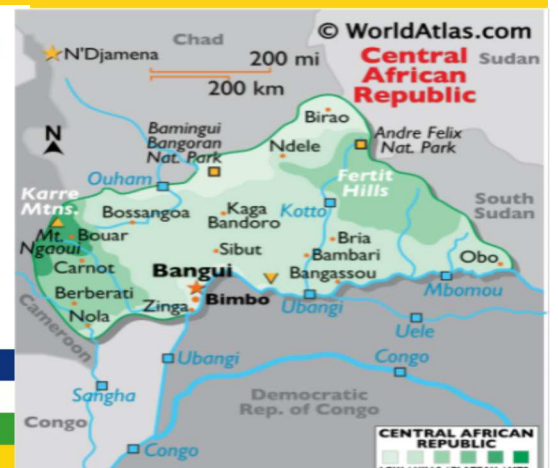
Ms. DeAndrea V. Cartwright is a career Foreign Service Officer currently stationed at the Permanent Mission of the Commonwealth of The Bahamas to the United Nations in New York. She has previously served at the Embassy of The Bahamas to the Republic of Haiti. Having arrived in New York in late 2018, Ms. Cartwright has since held principal responsibility for Social, Cultural and Humanitarian Affairs which includes matters relating to Human Rights. Ms. Cartwright joined the Ministry of Foreign Affairs in late 2013 and has served in several areas of the Ministry, including the Divisions of Legal Affairs and International Relations. She has also worked at the Bureau of Women's Affairs, now Department of Gender Affairs, within the Ministry of Social Services and Urban Development. Ms. Cartwright has worked with matters relating to Human Rights since 2014 and benefitted from several courses and trainings facilitated by OHCHR, UNHCR and UNITAR. As a member of the National Inter-Ministerial Reporting Mechanism, She was extensively involved with the drafting of several national Reports to Human Rights Treaty Bodies, including CEDAW and UPR.

This is her first time in attending a regular session of the Human Rights Council.

N'Gbeng-Mokoue has been a Human Rights Officer since 2016 in the office of the Minister of Justice and Human Rights of the Central African Republic (CAR). Since then, he has chaired the National Inter-Ministerial Committee that is in charge of drafting the country's reports under the international legal instruments relating to Human Rights.

Mr. N'Gbeng-Mokoue holds a Master's degree in public law specializing in international relations, from the University of Bangui. He is a former student of the National School of Administration and Magistracy, holding a post-graduate diploma in Administrative Litigation. Mr. N'Gbeng-Mokoue briefly began his professional career at the Council of State (Administrative Jurisdiction) before working in the ministerial cabinets, in particular that of the Prime Minister, from 2001 to 2003. He has also obtained several certificates in the field of Human Rights, notably at the International Institute of Public Administration in Paris, the International Institute of Human Rights in Strasbourg and the Ecole Nationale d'Administration in Paris.
