Subject: Applications for the vacancy of Independent Expert on issue of human rights obligations related to the enjoyment of a safe, clean, healthy and sustainable environment

The Secretariat of the Human Rights Council presents its compliments to all Permanent Missions to the United Nations Office at Geneva, international organizations or their offices, national institutions, nongovernmental organizations, and other human rights bodies, and has the honour to inform them that the above-mentioned mandate-holder is to be filled at the twentieth session of the Human Rights Council (18 June - 6 July 2012). The mandate was established by Council resolution (A/HRC/RES/19/10) at its nineteenth session (27 February – 23 March 2012), a copy of which is attached. The Consultative Group established in accordance with paragraph 47 of Annex to Council resolution 5/1 is mandated to propose a list of candidates to the President of the Council one month prior to the Council's twentieth session. In order for the Consultative Group to implement this mandate, individual candidates, including those nominated by entities, must submit applications to this vacancy by <u>7 May 2012</u> (midnight, GMT) through the new on-line application procedure as indicated above. Attention is drawn to paragraph 42 of Annex to Council resolution 5/1, which indicates that the following entities may nominate candidates: (a) Governments, (b) Regional Groups operating within the United Nations human rights system, (c) international organizations or their offices, (d) non-governmental organizations, (e) other human rights bodies, and (f) individual nominations. Attention is also drawn to paragraph 22 (a) of Annex to Council resolution 16/21 of 25 March 2011 which provides that national human rights institutions in compliance with the Paris Principles may also nominate candidates.

Furthermore, paragraph 22 (b) of Annex to Council resolution 16/21, stipulates that individual candidates and candidates nominated by entities shall submit an application for each specific mandate, together with personal data and a motivation letter no longer than 600 words. In accordance with the new procedure the Office of the High Commissioner for Human Rights shall prepare a public list of candidates who will apply for each specific vacancy.
