






Implementing the UN Guiding Principles on Business and Human Rights: Discussion paper on national implementation Plans (June 2012)

### A.Process

- i. Separate UNGPs and CSR plans
- ii. National baseline study and gap analysis
- iii. Clear ownership within government
- iv. Periodic monitoring and progress reporting verifiable criteria
- v. Participatory vulnerable rights-holders, inside and outside home state jurisdiction
- vi. Transparent and adequately resourced

# B.Minimum content vii. Address full scope of UNGPs across all 3 pillars viii. Address EU regional standards as well as UN etc. ix. Achievable targets, milestones and performance indicators
