Consultation for a thematic Study on Participation of Persons with Disabilities in Political and Public Life

Dear Mr Walker,

I am pleased to provide you with the EU Agency for Fundamental Rights' (FRA) contribution to the above-mentioned consultation.

In the FRA report on the right to political participation of persons with mental health problems and persons with intellectual disabilities (available at: http://fra.europa.eu/fraWebsite/research/publications/publications_per_year/p ub-vote-disability_en.htm), the FRA presents a comparative law analysis of the legal barriers faced by these individuals. The majority of EU Member States still have legal barriers preventing them from voting and being elected (see pp. 15 ff. of the report). The report also introduces the situation in EU Member States which do not impose any restriction on the right to vote (see pp.19 f. of the report). While the report does not address good practices as such, it refers to legal adaptations that facilitate the political participation of persons with disabilities (see pp. 21 f. of the report).

The above-mentioned report (available in English, French and German in print and in 18 other language versions online) is the first publication in the context of the FRA disability project on the Fundamental rights of persons with intellectual disabilities and persons with mental health problems.
