





How can human rights contribute to the protection of the environment?

Thursday 22 September 2016, 10:00-12:00, International Environment House II

You are cordially invited to attend a panel discussion on how can human rights contribute usefully to the protection of the environment.

On 13 September, the UN Special Rapporteur "on the implications for human rights of the environmentally sound management and disposal of hazardous substances and wastes", Baskut Tuncak, will present his report to the Human Rights Council on the rights of Children affected by hazardous substances and wastes. On 20-21 September, the UN Special Rapporteur "on human rights and environment", John Knox, will conduct an expert meeting on biodiversity and human rights, in the perspective of the report he will present to the Human Rights Council in March 2017. The Paris Agreement on climate change adopted in December 2015 includes a number of strong preamble references to human rights, for which 27 UN Special rapporteur had made a joint call in 2014.

In the presence of the two Special Rapporteurs mentioned above and of some or the heads of environmental international organizations, the latest contributions of the human rights field to the protection of the environment will be reviewed. Questions, challenges and achievements concerning the strengthening of the relation between these two fields will also be discussed.
