The Housing Schemes provided by the Ministry of Interior include schemes especially tailored for population displaced from their homes, due to the 1974 Turkish invasion.

The fundamental objective of Housing Schemes for the displaced persons is the securing of a satisfactory level of living and acceptable housing conditions for displaced families until the solution of the Cyprus Problem and the return of all to their properties.

The Council of Ministers decided (Decision No.5.317, dated 19/6/2013), to recognize children of internally displaced person (IDP) mothers as displaced persons, entitled to all rights the children of IDP fathers have regarding existing benefits (Housing Schemes). The necessary legislative amendment was approved by the House of Parliament and published in the Government Gazette on 27/12/2013.

## The Housing Schemes for displaced persons are the following:

## [A] 1. Self-help Housing on Private Land

Under this scheme applicants are granted financial aid in order to build a housing unit on their own private land. Eligible applicants are considered those that are displaced persons and meet the income threshold, provided that they do not own another housing unit (or owned such a unit in the past). The amount of the aid is determined by the applicant's income and the size of his family. The aid for building a house is set as follows:

# [B] Purchase of Apartment/House Scheme

Under this scheme applicants are granted financial aid in order to purchase a housing unit. Eligible applicants are considered those that are displaced persons and meet the income threshold, provided that they do not own another housing unit (or owned such a unit in the past). The amount of the aid is determined by the applicant's income and the size of his family. The aid for purchasing a housing unit is set as follows:
