In accordance with Article 43.2 of the Constitution of the Republic of Azerbaijan, the state contributes to the construction of houses and takes special measures for realization of housing rights of people.

In accordance with the decree # 569 signed by the President of Azerbaijan on June 20, 2014 on "Additional measures to improve the social and living conditions of martyrs' families and those who have become disabled for the territorial integrity, sovereignty and constitutional order of the Republic of Azerbaijan" persons in need of improved housing conditions registered as such with local bodies of executive power as of January 1, 2014 will be provided with apartments or single-family houses by the Ministry of Labour and Social Protection of Population during 2014-2018.

Within the period 1999 – 2016, the Ministry of Labour and Social Protection of Population provided 5425 persons who became disabled as a result of war injuries and martyrs' families with housing at the expense of the state.
