ATTACHMENT L. THE IMF AND HUMAN RIGHTS

Key messages

The IMF's activities indirectly promote human rights (in particular, social and economic rights) by helping create an economic and institutional environment in which human rights can flourish. Thus, our policy advice and financial assistance support economic growth and improvements in living standards in member countries, and foster critical institutional reforms that strengthen good economic governance and respect for the rule of law. Key examples in this regard include the IMF's work on gender equality and the MD's participation in the UN High Level Panel on Women's Economic Empowerment, work promoting economic policy transparency, and improving governance.

Nevertheless, the mandate of the IMF is defined by the Articles of Agreement and its powers and responsibilities are limited to those entrusted to it by the membership. *This mandate focuses on macroeconomic and financial stability and does not, unlike the constituent documents of some other international organizations, encompass the promotion of human rights per se*. As an institution that is concerned with economic issues, the IMF is precluded from using its powers to support particular political systems or, directly engage in the promotion of human rights.

Background

The Office of the High Commissioner for Human Rights (OHCHR) has previously sought the Fund's collaboration in discussions on the "Right to Development" and other matters considered to be affected by economic policy. Fund staff has participated in discussions with OHCHR staff and intergovernmental representatives on these limited issues. More recently the issue of debt and human rights has come up in the UN General Assembly (Third Committee) and a UN Independent Expert has been commissioned to report on international financial institutions and human rights in 2017. Fund staff has also collaborated with UN agencies in their pursuit of some of their mandated objectives, many of which are formulated through a "rights-based" approach. Examples of this are the collaboration with UNICEF, whose work is guided by the "Rights of the Child," and with the ILO (which seeks to promote labor rights, core labor standards, collective bargaining).

The IMF has not accepted the Declaration on Human Rights as the motivating principle of our operations. UN agencies have generally accepted our arguments as establishing the limits of our engagement and obligations on promoting human rights.
