WHAT IS THE ROLE OF ECLAC?

The overall purpose of ECLAC is to promote the economic, social and environmentally sustainable development of Latin America and the Caribbean through continuous international cooperation.

ECLAC main activities are:

Research and data

Undertake research and analysis and disseminate information and data relating to the economic and social development of the region.

Technical cooperation

Provides advisory services to Governments and plan, organize and execute programmes of technical cooperation.

Training + capacity building

Provides training to technical staff and decision makers in public authorities, as well as academic experts and opinion makers in civil society.

Dialogue

Provides for intergovernmental platforms for policy dialogue, peer learning and normative discussion.

ECLAC AND WASH

ECLAC Secretariat's Division of Natural Resources function focuses on strengthen the institutional capacity of the countries to improve the governance, policies, management and sustainable use of natural resources and associated ecosystem and basic services, in accordance with the principles of sustainable development. Management of regional water-related conflicts and challenges



In December 2020 it published a <u>study</u> on the importance of Social protection for families with children and adolescents in addressing the impact of COVID-19 in the region.

I would like to develop a global mapping of the situation on water disconnections - both in the context of COVID19 crisis and beyond - particularly for those who are not capable of paying for water. I have started this exercise in the Latin America region (GRULAC) and look forward to working on this with the Economic Commission for Latin America and the Caribbean.
