Understanding Urgent Actions

Urgent Actions allow the Committee on Enforced Disappearances to intervene when informed of the disappearance of a person by requesting the State party concerned to take immediate action to search for a disappeared person, investigate his or her alleged disappearance and determine the person's fate and whereabouts. This procedure applies to all States parties to the Convention.

Requests for urgent action can be submitted by the relatives of the disappeared person or their legal representatives, their counsel or anyone authorized by them, as well as by any person with a legitimate interest.

This procedure has had a significant impact: as at 18 December 2023, 1671 requests for urgent action have been registered. Out of these cases, 475 disappeared persons have been located, 445 of whom alive.

Other advantages of this procedure include:

- Raise the issue at the international level, moving from a bilateral relationship between victims and the State to a tripartite relationship with the support of the Committee.
- Inform the State party concerned of cases of which the competent authorities are unaware, and provide information and guidance on the measures they should take to search for the disappeared person and investigate his or her disappearance and protect the victims, in compliance with the Convention.
- To make cases of enforced disappearance visible at the international level.

The Committee is competent if:

- The alleged disappearance started after the entry into force of the Convention (23/12/2010);
- It took place on the territory of a State party to the Convention; or
- It was perpetrated by agents of a State party to the Convention, or with its authorisation, support or acquiescence;
- In principle, the Committee is also competent when the disappeared person is a national of a State party.

Once an urgent action is initiated, the Committee guides the State with specific recommendations, overseeing search operations, investigations, and victim assistance until the disappeared person is located. Throughout the procedure, communication is maintained between the Committee, State authorities, and authors of the urgent action request.

<u>The format for the submission of Urgent Action requests</u> to the CED is available as a guide to submit a case of disappearance to the attention of the Committee.

Closed Meetings



UN Voluntary Fund for Victims of Torture Grant Applications

The United Nations Voluntary Fund for Victims of Torture (UNVFVT) awards grants to victims of torture, civil society organizations, survivor-led associations, rehabilitation centres and public interest law firms. As of today, approximately 25% of the projects that receive a grant from the Fund are here to help and support victims of enforced disappearances. Supported services include social, psychological, medical, legal, and humanitarian aid.

The annual grant application period, running from 15 January to 01 March 2024, offers a crucial opportunity for organizations to apply for funding to aid victims of enforced disappearance.
