

### Introduction



The Committee on the Rights of Persons with Disabilities is part of the **United Nations.** We work to make sure that governments are following the **Convention on the Rights of Persons with Disabilities**.



The **United Nations** is an organisation made up of many countries working together. They work to make the world a safer and better place.

The Convention on the Rights of Persons with Disabilities is an agreement which tells governments what they need to do to make sure persons with disabilities have the same rights as everyone else.



Every person is born with rights and they are protected by laws.

**Rights** are things that every person should have by law. Like the right to be safe, the right to education, the right to be respected.

There is not a right to be respected. I think even it's Easy Read, we should use the right term. Right to life, Right to health, Right to education, Freedom of expression, Right to personal security and liberty.....



Persons with disabilities have the right to live independently and be included in their communities.




But instead, many persons with disabilities around the world are kept in **institutions**.

An **institution** is a place where persons with disabilities live together and are kept apart from their community.




There are different types of institutions, like hospitals and group homes.

Persons with disabilities are often treated very badly in institutions.



This Easy Read document will tell you about institutions and our guidelines about what governments should do to move people out of them.

### **Institutions**



When you live in an institution you do not have the same rights as everyone else, because:




 You can't choose the support or assistants you want.



• You are not included in your local community.



 You are not allowed to make your own decisions.

• You have to do the activities the institution wants you to do.



 You are not allowed to choose where you live and who you live with.

## The guidelines

I think it would be more helpful to put "Stop" in front of each point so readers won't be confused.

### We want governments to stop:

Stop putting people into institutions

Stop spending money to improve institutions or make them bigger.

All institutions should be closed down.

Many governments have tried to move people from institutions into communities before, but failed.



Shall we convey more about "rights" rather than the "move"?

Our guidelines show governments how to move people from institutions without them losing their rights.





Use the same drawings of institutions from the beginning.

- Any laws that support institutions or create new institutions should be removed.

2. Any laws or rules that stop people from making their own decisions should be removed.




Use the same drawings of institutions from the beginning.

3. Governments must stop spending money on these laws and institutions.



 Instead, governments must spend money on support for persons with disabilities, to help them be part of their local communities.

As above, can't really tell these are money and we need to see the guidelines and what does it mean by following it.



This doesn't really look like lots of support.




 Provide lots of support services for persons with disabilities in their local communities.



It might be more communicative if we can show "choosing" and also "affording"

 Support persons with disabilities so they can afford and choose their own care and support.



Perhaps there's a way to show living well and in the way they want to?

 Support persons with disabilities so that they can afford to live well and in the way they want to.



Anything we can add to show "affordable"?
Possibilities to show "housing that suits their needs"?

 Provide affordable housing for persons with disabilities which suits their needs.



Wheelchair users too? Persons with visual impairments? Using hearing aids? This can be used in the previous point about involving PwDs?

 Involve persons with disabilities and their organizations in any decisions that are made about them.



 Let persons with disabilities choose to receive support from their families if they want, and give money to the families to help with this.

 Provide support for older persons with disabilities to stay in their own homes.



 Give each person with disabilities personal support that is right for them.



- Make sure that everyday services are easy to use for persons with disabilities, like:
  - Health care.
  - Jobs.

A resident permit doesn't look like this.



 Residence permits - these say you are allowed to live somewhere.

 Voter registration - this says you are allowed to vote.

• Employment numbers - you need these to get a job.

 Passports - these let you travel to other countries.





Illustration can show Easy Read information.

 Provide persons with disabilities who are leaving institutions with information about services that is easy to understand.



I think the layout is quite confusing... a sudden change of topic is not very user-friendly.

 Carry on closing down institutions, even when emergencies are happening, like:



 Pandemics - this is when a disease is spreading around the world

I think this is much better and more accurate description.

 Natural disasters - these are problems caused by the Earth, like floods, hurricanes and earthquakes.



This might not be the best way to depict conflicts.

 Conflicts - this is when there is fighting or war. Cannot tell those are money, don't see how this person was harmed and what kind of support or services



 Provide money, support and services for anyone that has been harmed while living in an institution.



 Collect information about how well they are helping persons with disabilities to leave institutions.



Not sure this will convey the message to users.

 Make sure that the rest of the world can clearly see everything they are doing to help persons with disabilities leave institutions.

# Unfair treatment of certain groups




Persons with disabilities are all different, and their disability is only one part of who they are.



Not sure if this can really depict "unfair treatment" and intersectionality.


Might be confusing to some users, thinking being yelled at is unfair treatment (a bit out of context)

Other things may cause persons with disabilities to suffer from more unfair treatment, like their race, sex, age, gender or sexual orientation.





Governments should think about how certain groups of persons with disabilities will be affected while institutions are being closed down and people are leaving them.



### Governments should make sure that:

# Women and girls with disabilities

Women and girls with disabilities are more likely to:



• Be treated unfairly.



There are different kinds of violence, e.g. verbal, physical, mental and sexual.

• Suffer violence.

• Be abused - this is when someone hurts you or treats you badly.




 Stopped from making their own decisions.





Governments should think about this while institutions are being closed down and persons with disabilities are leaving them.

# Children with disabilities



All children have the right to grow up in a family.

There are many definitions of family now, perhaps we need to depict more than just one kind of family models



Governments should make sure that children with disabilities can grow up in a family and not in an institution.



It might be more communicative if we can see the "moving out" part.

Children who live in institutions need to be moved out so they can grow up in a family like other children.

#### Other general comments:

- Consider a different layout to help grouping information for easier access.
- When possible, try not to do too many layerings of bullet points. It gets confusing when the list is long and focus will be lost.
- As an UN documentation, the representation of ethnicity, particularly Asians, is not diverse enough.
- The concept of family and gender is not up to date.
- Certain areas are not universal to different countries and need to reconsider wordings.
- A lot of pictures do not really mean anything on its own and for Easy Read, it's best to think of pictures as the primary communication tool and text as a supplement.
- Consistency of pronoun will help with understanding too.

#### Concept:

- Human rights are innate to all human beings. They are protected by law but not granted by law. So I think we should rewrite the part on the explanations of what rights mean to us.
- Because of that, persons with disabilities HAVE the right to live independently, not "should have". I think these are very important concepts that we need to be clear about.
