### 4. Background / Context

#### The World Youth Parliament for Water:

The World Youth Parliament for Water (WYPW) is a network of passionate young people from over 80 countries supported by the International Secretariat for Water. We aim to raise awareness among the youth working in the water sector, and our members take action on water issues at all levels: from concrete actions in local communities, to advocacy for youth leadership in the water sector. More specifically:

We Raise Awareness: We recognize young water leaders as change makers who can advance the values of equity, peace, and a healthy environment within the water sector. Outside the water sector, we lead efforts to improve water education, especially for youth, in all countries.

We Advocate: We mobilize youth to speak with a lens on the future for peaceful and sustainable water management for the long-term. We push for more youth representation in established institutions and organizations.

We support Local Action: We work with and support young people committed to decentralized projects on a community level. Access to safe water and sanitation and the healthy management of basins is not possible without including local contributions.

We Research: We conduct research, to improve our understanding of the connections between the environment, society and of the multitude of perspectives related to water resources management.

The WYPW is a proud member of UN-Water and has, as such, proactively partaken to numerous United Nations General Assemblies. But not only, we were most recently present during the Dushanbe Water Process and the Dakar World Water Forum, among many other events.

# Our reasoning behind the organization of this side-event:

This year's Social Forum will focus on water for human rights and sustainable development. On good practices, lessons learned and challenges in the implementation of the International Decade for Action, "Water for Sustainable Development", 2018–2028, with a view to making a human rights contribution to the conference on the midterm review of the Decade, to be held in 2023. Every three years, the WYPW holds a General Assembly during the World Water Forum, to identify new members, elect new representatives, and especially, to plan our collective actions as a network and a partner for the following three years - until the next General Assembly meets. This year, our General Assembly adopted in Dakar a WYPW Statement that, for the first time, will be guiding all of our interventions and actions for the upcoming years and, namely, our preparation and advocacy efforts towards the UN 2023 Water Conference. In it, we specify not only our vision but also our objectives as a youth water network, and we list concrete actions that everyone within the water sector could implement, to help us reach the objectives.

Because, at the end of the day, the youth demographic represents a significant source of skills, innovations and agency for solving water and sanitation problems in the context of climate change, connecting local communities and ready to take the necessary risks in a rapidly changing world. Yet "youth" (people under the age of 35, who represent more than half of the global population and who are among the most affected populations by global crises such as water conflicts and ineffective water governance, climate change, and pandemic-related economic crises), they are not meaningfully included in the majority of the decision-making processes around water. And, at the World Youth Parliament for Water, we firmly believe that the integration of the vision and the actions listed in our network's statement that we will be presenting during our side-event would significantly contribute towards a successful UN Water Action Decade.
