# Antigua and Barbuda

Joy Dublin-Baptiste

Senior Crown Counsel, Attorney General's Chambers



Mrs. Joy Dublin-Baptiste joined the Attorney General's Chambers as Crown Counsel in 2017, when she assumed responsibility for matters of general litigation. She now serves as Senior Crown Counsel on the litigation team. In this capacity she works closely with the Antigua and Barbuda's Family and Social Services Division and is dedicated to providing practical assistance to the State's vulnerable, abused, and neglected children. Her interest in the rights of the most vulnerable was sparked when she taught children who were blind and/or visually impaired after completing her premier tertiary training in Education. Her core interests in disability rights and the issues faced by children in need are the foundational pillars upon which she has built her legal career.

Prior to her work in the public service, Mrs. Dublin-Baptiste worked as an Attorney in the chambers of James Dublin and Associates, where she gained a range of legal experience in the areas of civil litigation.

Mrs. Dublin-Baptiste, who is also a certified mediator, holds an LLM in Legislative Drafting from the University of the West Indies, Cave Hill (2019) and an LLB (Hons) from the University of Wolverhampton (2006). She is a member of the Honourable Society of the Middle Temple and was called to the Bar of England and Wales in 2009. After completing the Legal Education Certificate at Norman Manley Law School, Mrs. Dublin-Baptiste was called to the Bar of Antigua and Barbuda in 2010.

Andy Gérard Olouwatogni Agossou

Chef du Service des droits humains à la Direction des Affaires juridiques, Ministère des Affaires étrangères



Diplomate de carrière, Monsieur Andy G. Olouwatogni AGOSSOU est Conseiller des Affaires étrangères et a intégré le Ministère des Affaires étrangères en 2009. Il a occupé depuis sa prise de service plusieurs postes de responsabilité dont celui de coordination du Service des Organisations internationales à caractère social et culturel au sein de la Direction des Organisations internationales où il a contribué significativement, en lien avec les services nationaux compétents, à la mise en œuvre de la politique nationale de lutte contre l'abus des stupéfiants et des substances psychotropes et à une meilleure orientation des travaux du Comité d'éligibilité de la Commission nationale d'assistance pour les réfugiés. Il a également servi à la Direction de l'Amérique, et occupé le poste de Chef du Service des Etats-Unis d'Amérique p.i. où il était chargé des dossiers de coopération entre le Bénin et ce pays. De 2017 à 2020, il a occupé les fonctions de Conseiller/Chef de Chancellerie à la Délégation permanente du Bénin auprès de l'UNESCO où il avait la responsabilité de la gestion administrative, financière et protocolaire ainsi que celle de la représentation du Bénin au Comité du Siège de l'UNESCO.

Chef du Service des droits humains à la Direction des Affaires juridiques depuis 2022, il assure sous le leadership de sa hiérarchie le suivi de tous les dossiers liés à la promotion, à la protection et à la défense des droits humains. A ce titre, il a participé activement aux préparatifs du passage du Bénin en janvier 2023, au quatrième cycle de l'Examen périodique universel. Il joue un important rôle pour la réussite du mandat du Bénin en sa qualité de membre du Conseil des droits de l'Homme pour la période 2022-2024. Il représente le Ministère des Affaires étrangères au sein de divers comités traitant des questions des droits humains notamment le Comité technique de gestion de lutte contre la traite des personnes et le Comité Directeur national de lutte contre le travail des enfants.

## The Gambia

### Aji Adam Ceesay

**Curator of Intestate Estate and Head of the Human Rights Unit, Attorney General Chambers and Ministry of Justice**



Ms. Ceesay is a legal practitioner working with the Ministry of Justice. She joined the Ministry of Justice in 2012 and since then assumed many responsibilities in different departments at the Ministry. Currently, Ms. Ceesay is heading the Curator of the Intestate Estate Department as the Curator. She also leads the Human Rights Unit of the Ministry of Justice. Part of her responsibilities include representing the State in criminal, civil and international matters in national and international courts. Ms. Ceesay also participates in bilateral and multilateral negotiations on behalf of the Gambia Government.

As the Head of the Human Rights Unit, she coordinates the Gambia's Treaty Bodies reporting obligations under the Inter-ministerial Task Force. She also trains the police and other security agencies on human rights issues and domestic legislation.

Ms. Ceesay obtained her LLB at the University of the Gambia in 2011, her BL at the Gambia Law School, and enrolled as Legal Practitioner in 2013.

Mr. Mendes joined the Foreign Ministry of Guinea-Bissau in 2007 and was admitted to the diplomatic career in 2008. From 2008 to 2010, he worked as third secretary placed at the Division of Human Resources, in charge of Section of Personnel, and then served as Head of Human Resources Division from 2010.

Mr. Mendes attended the diplomatic training course at the Foreign Service Academy of Islamabad, Pakistan (2010-2011) and was promoted to second secretary in 2012. From 2016 to 2018, he served as Chargé d'Affaires a.i. at the Embassy of Guinea-Bissau to the Federal Republic of Nigeria in Abuja, and as First Secretary at the same Embassy from 2018 to 2020, where he was in charge of ECOWAS/multilateral matters and served as head of the consular section.

From 2021 to present, Mr. Mendes serves as Counsellor at the Permanent Mission of Guinea-Bissau to the United Nations in New York in charge of the 3rd and 4th Committees, and as election officer.



Mr. Mendes holds a B.Sc. in Political Science and is fluent in Portuguese, English and French.



Ms. Kaunda is the head of the Human Rights Section at the Ministry of Justice, Malawi. She has served in the following positions: Legislative Counsel in the Legislative Drafting Section (2010-2018); seconded Junior Counsel, Advisory Centre on WTO Law (ACWL), Geneva (2014-2015); and Senior State Advocate, Civil and Criminal litigation (2008-2010). Prior to joining Malawi Government, she was a Research Assistant for Alun Jones, KC, Great James Street Chambers, United Kingdom (2002 to 2006). Among other responsibilities, Ms. Kaunda has coordinated Government's responses to human rights issues and facilitated Malawi's compliance to international obligations on human rights conventions which Malawi is a party to. Ms. Kaunda has represented Malawi at various local, regional and international human rights fora. She has also coordinated the drafting of various State Party reports for Malawi to the United Nations Treaty bodies and African Union, including the (third cycle) Universal Periodic Review Report (2020) and Malawi's initial report under the International Covenant on Social, Economic and Cultural Rights (2022).

Ms. Kaunda holds an LL.B. (Hons) degree from the University of Buckingham, United Kingdom, (2001), an LL.M. degree in Banking and Finance Law from University of London, United Kingdom (2003) and a Post graduate Diploma in Legislative Drafting, Commonwealth Secretariat (2010). Ms. Kaunda was admitted to the Bar of England and Wales (Honourable Society of the Inner Temple) (2002) and to the Bar of Malawi (2010).

# Maldives

**Nafha Hassan**

**Assistant Director, Human Rights Division, Ministry of Foreign Affairs**



Ms. Nafha Hassan is an Assistant Director currently serving at the Human Rights Division of the Ministry of Foreign Affairs of the Maldives, where she facilitates the execution of national foreign policy goals pertaining to human rights. Prior to working in the Human Rights Division, Ms. Hassan served the United Nations Division of the Ministry of Foreign Affairs for over three years with the portfolio on execution of Maldives engagement at the United Nations. She has undertaken critical analysis on the resolutions adopted in the UN General Assembly sessions that inform policy decisions on emerging issues in the United Nations, including humanitarian issues deliberated in the Third Committee of UNGA.

Ms. Hassan joined the foreign service as a Desk Officer in September 2019 and has been an active player in mediating the engagement of Maldives in several agencies of the United Nations in coordination with the UN Country Team in the Maldives. Also, she has contributed to the campaigns that led to the election of the Maldives to the Presidency of the 76th United Nations General Assembly in 2021 and to the recent election of Maldives to the Human Rights Council session for the term 2023-2025.

During her time in the United Nations Division, she has had the opportunity to be part of the President's delegation to the 76th United Nations General Assembly and had the opportunity to participate in diplomatic trainings.

Ms. Hassan graduated from the Maldives National University with a B.A. in Political Science and International Relation and at present is completing her Masters in Political Science and International Affairs.





Il a pris part à l'élaboration et à l'examen de plusieurs rapports du Togo dont le rapport au titre du 3ème cycle de l'examen périodique universel (EPU) en 2022 lors de la 40ème session du groupe de travail sur L'EPU et à l'adoption des résultats finaux de l'EPU du Togo en juin 2022, ainsi que du rapport initial sur la mise en œuvre de la Convention relative aux droits des personnes handicapées en mars 2023 à Genève en Suisse.

Monsieur AKPAOU fut successivement Chef de la division de l'assistance aux victimes et des relations avec la société civile (2014-2018) et Chef de la division de la législation et de la rédaction des rapports initiaux et périodiques (2018-2020) dans le même ministère. Il prend part en qualité de délégué d'Etat aux travaux des sessions ordinaires de la Commission africaine des droits de l'homme et des peuples. Il participe à l'élaboration et aux travaux en commission sur les lois à l'Assemblée nationale.


