Antigua and Barbuda

Zachary Phillips Crown Counsel at the Attorney General's Chambers

As Bangladesh has been providing humanitarian assistance to the forcibly displaced Rohingyas who fled from Myanmar, steering resolutions titled 'Situation of human rights of Rohingya Muslims and other minorities in Myanmar', and 'Human Rights and Climate Change', playing an active role in the areas of right to development and promotion and protection of rights of migrant workers and women in the Human Rights Council, Ms. Sumaiya possesses a keen interest and eagerness to learn, collaborate, and develop the skills necessary for effective advocacy in the fields of human rights, humanitarian diplomacy and multilateral negotiation.

Ms. Sumaiya joined the Ministry of Foreign Affairs in 2021. She holds a Bachelor of Medicine and Surgery (M.B.B.S.) degree from Faridpur Medical College.
