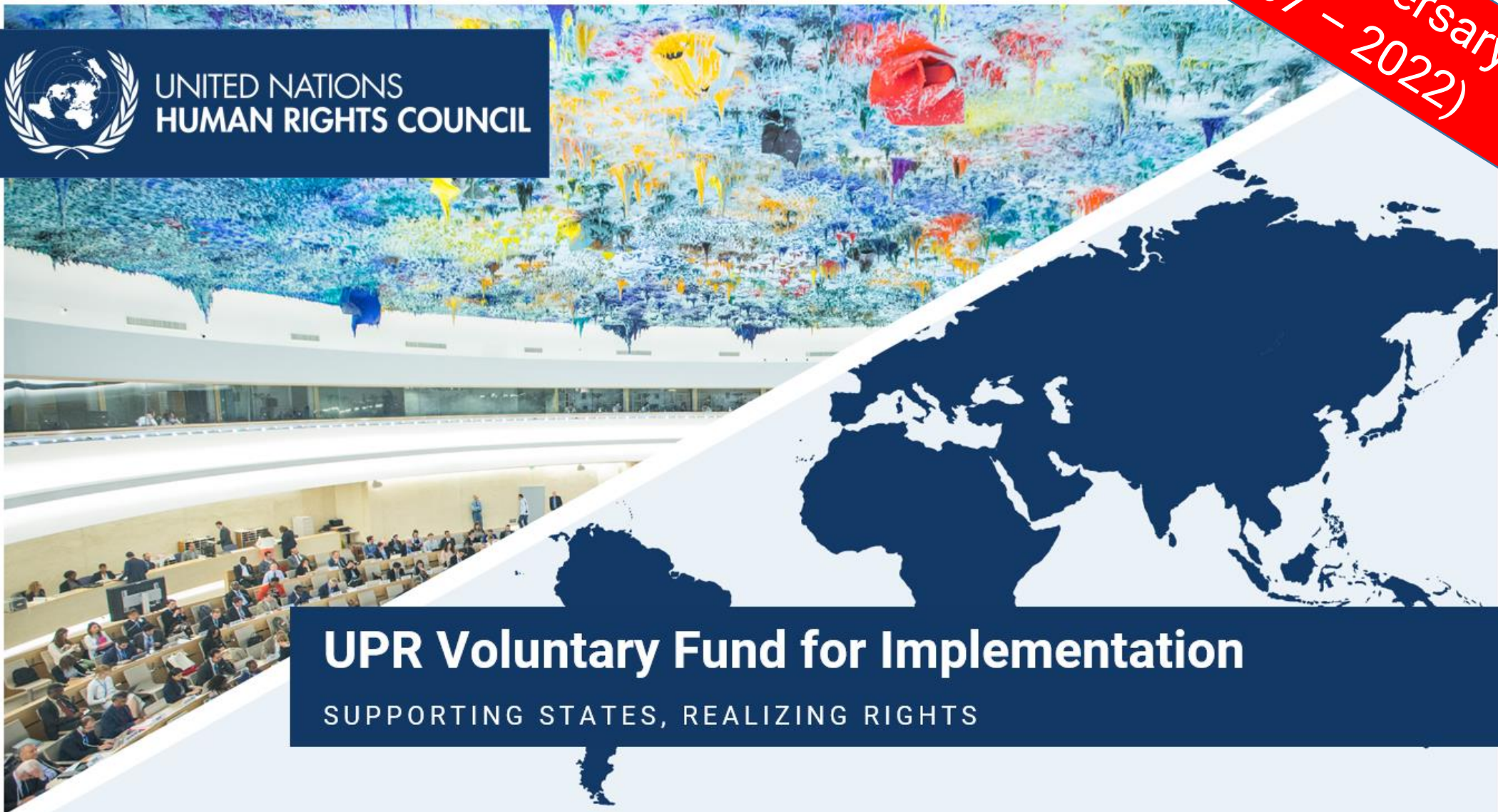

Mandate



The **Voluntary Fund for Financial and Technical Assistance in the Implementation of the Universal Periodic Review** was

established in 2007 by Human Rights Council resolution [6/17](#) and further strengthened in 2011 by resolution [16/21](#).

The fund provides financial and technical assistance to support countries, in particular least developed countries and small island developing States, to implement recommendations emanating from the universal periodic review in consultation with, and with the consent of, the country concerned.

A Board of Trustees, appointed by the Secretary General and composed of human rights experts from all regions, provides advice and guidance on policy orientation and strategy in the operationalization of the Fund.



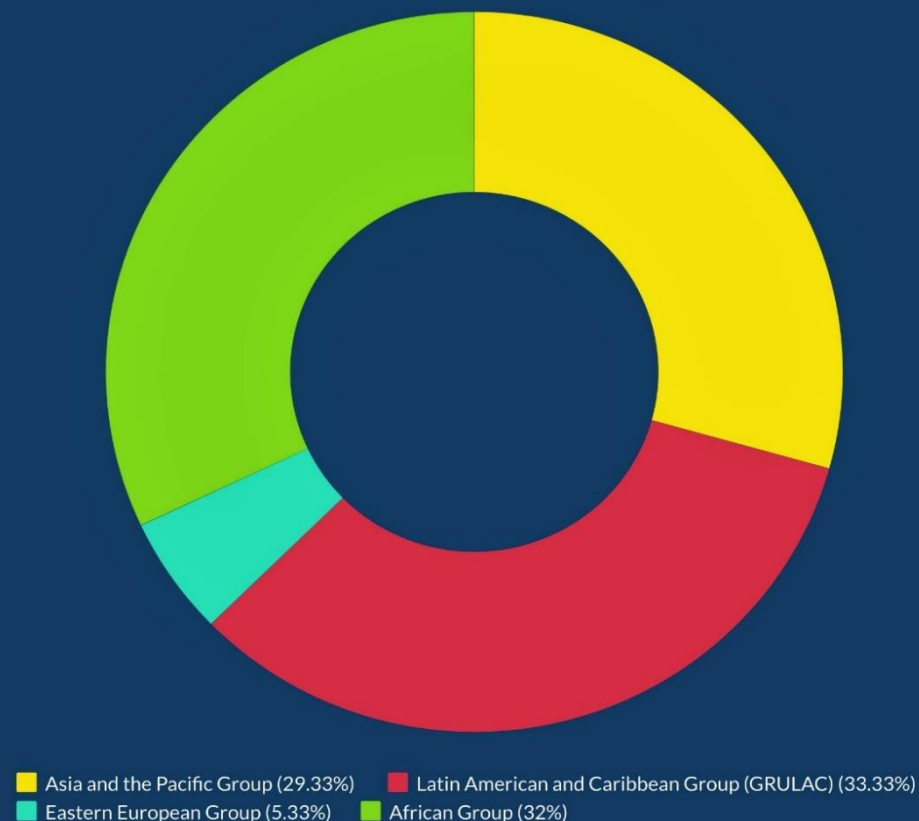
Facts and figures

The Voluntary Fund provides seed funding aimed at enhancing national capacities in one or more of its established focus areas, creating synergies between the **implementation of key universal periodic review recommendations**, the strengthening of Governments' institutional capacity to ensure a **comprehensive follow up and reporting** on the progresses achieved, the **enhancement of the role of Parliaments**, and the **strengthening of the United Nations country teams** to support national efforts to implement human rights mechanisms recommendations and integrate them with initiatives to achieve the Sustainable Development Goals (SDGs).

Since its establishment, the Voluntary Fund has disbursed **USD 5.485.384**, providing support to activities in **76** countries and allowing the organization of **8** regional workshops to promote the sharing of good practices.

As a result of the enhanced focus on implementation of recommendations during the third UPR cycle, the fund has progressively increased annual funding of projects and, following the easing of COVID-19 restrictions in various regions, will reach an annual implementation of about USD 1.000.000 by the end of 2022.

In **Moldova**, the Fund supported the Permanent Human Rights Secretariat in developing a guide on national mechanisms for monitoring and reporting on the implementation of human rights recommendations and a roadmap to link the National Human Rights Action Plan with the SDGs.

In **Kyrgyzstan**, the Fund supported the implementation of a legal inventory of the national legislation to bring it in accordance with international human rights standards. An in-depth human rights analysis of 18 laws was carried out, focusing on issues of non-discrimination and protection of groups in a situation of vulnerability.

Through a **regional consultation in Panama** on the universal periodic review and the 2030 Agenda, government officials and UN representatives from 17 countries shared good practices regarding the implementation of UPR recommendations and identified challenges and opportunities to align national initiatives to achieve human rights and the SDGs.

In **Chad**, the Fund is supporting the strengthening of the national mechanism to monitor places of detention and the drafting of a law on human rights defenders.

In **Mongolia**, the Fund supported the establishment of the national preventive mechanism against torture and the adoption of a law on human rights defenders.

In **Costa Rica**, the Fund is supporting a participatory assessment on the access to justice of four indigenous peoples, which will allow the Judiciary to develop a policy on the matter in line with international human rights standards.

In **Uruguay**, the Fund was used to support the work of the Parliamentary Penitentiary Commissioner in the elaboration of the *"Plan to combat recidivism and favor rehabilitation, based on a gender and human rights perspective"*.

In **Lesotho**, the Fund is supporting the strengthening of national human rights oversight bodies and promoting inclusion and access to equal opportunities for children left behind, in particular children herding domestic animals and marginalized urban children.



Facts and figures

Accepted universal periodic review recommendations have proven to be an **important entry point for creating nationally led and nationally owned processes** to implement the recommendations made by all international human rights mechanisms and integrate them with the efforts to achieve the 2030 Agenda and the SDGs. Such recommendations can also highlight areas in which early action is needed to address risks of human rights violations, therefore contributing to the United Nations agenda on prevention.

The **good practices** collected by OHCHR and other United Nations entities show that the universal periodic review has advanced the promotion and protection of human rights – in line with the Secretary General’s **Call to Action for Human Rights** and the resulting **UPR Practical Guidance** - and secured greater compliance, in law and in practice, with international human rights norms and with the commitments made by States in all regions of the world.



How to apply

Support by the Voluntary Fund can be requested by States in Geneva via a **Note Verbale** addressed to OHCHR or, at country level, via an **official communication** to the Head of the OHCHR field presence or the United Nations Resident Coordinator.



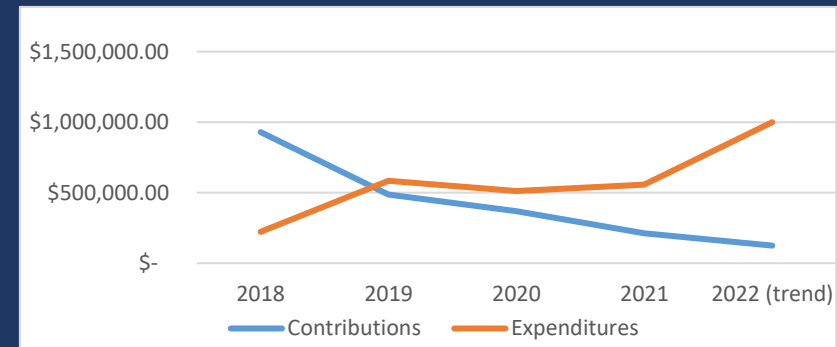
Support the Fund
