## REF: Inputs for the preparation of the report of the United Nations High Commissioner for Human Rights pursuant to Human Rights Council resolution 47/21

Your Excellency,

On behalf of the Inter-American Commission on Human Rights (IACHR), I have the honor of addressing Your Excellency to provide inputs regarding to "Promotion and protection of the human rights and fundamental freedoms of Africans and of people of African descent against excessive use of force and other human rights violations by law enforcement officers through transformative change for racial justice and equality".

## **Background**

- The IACHR is a principal and autonomous body of the Organization of American States ("OAS") whose mission is to promote and protect human rights in the American hemisphere. In 2005, the IACHR created the <a href="Rapporteurship">Rapporteurship</a> on the Rights of Afrodescendants and against Racial Discrimination due the racial disparities that have marked the history and politics of all the countries in the hemisphere.
- The President of IACHR, Margarette May Macaulay is the Rapporteur for the Rights of Persons of African Descent and against Racial Discriminations Commissioner. She is in her second term, having been re-elected on June 28, 2019, by the 49th General Assembly of the OAS for a four-year term which ends December 31, 2023.

## Inter-American treaties promotion and engagement

- The Inter-American Convention against Racism, Racial Discrimination, and Related Forms of Intolerance (Also known as "CIRDI"), was adopted in 2013 and entered into force in 2017.
- To date, it has been ratified by 6 States (Costa Rica; Uruguay; Antigua and Barbuda; Ecuador; Mexico, and Brazil).
- CIRDI provides that An Inter-American Committee for the Prevention and Elimination of Racism, Racial Discrimination, and All Forms of Discrimination and Intolerance shall be established and shall be comprised of one expert appointed by each of the States Parties who shall execute his or her functions in an independent manner and shall monitor the commitments undertaken in this Convention. The Committee shall be established when the first of the Conventions comes into force and its first meeting shall be convened by the General Secretariat of the OAS as soon as the tenth instrument of ratification of either Convention has been received.

In this report, the IACHR refers to ethno-racial violence in the context of the social protests of 2021, highlighting patterns of excessive use of force against Afrodescendants.

This report stands out that Brazil faces structural challenges to overcome aspects related to historical racial discrimination and its impact on Afro-descendants, Quilombola communities, and indigenous peoples.

This report examines the persistent situation of structural discrimination against people of African descent in the United States and, in particular, deep-seated racial disparities in policing and the criminal justice system.

# • *Human rights defenders and social leaders in Colombia, 2019.* Thematic report. In this report, the IACHR observes the main types of violence faced by human rights defenders and social leaders in Colombia. It highlights the differentiated attacks on Afro-descendant social leaders.

## Human Rights Situation in Honduras, 2019. <u>Thematic report</u>.

During the IACHR's visit to the Garífuna Community of San Juan, several community members stated that they occupy a small percentage of their lands and territories. This is due to the fact that the Honduran State granted property titles to third parties who were not members of the community. The IACHR also received testimonies indicating that many of the community members had to move due to pressure related to their territories from third parties.





#### Sentences of the Inter-American Court

- Case of the workers of the Fireworks Factory in Santo Antônio de Jesús and their families vs. Brazil. <u>Judgment</u> of July 15, 2020
   In this judgment, the Court addresses the intersection of factors of discrimination of the victims, who were poor, women, Afro-descendants, and in some cases, pregnant, and girls.
- Case of Acosta Martínez et al. v. Argentina. <u>Judgment</u> of August 31, 2020

  This is the first ruling on racial profiling in Inter-American jurisprudence. The Court emphasized that Acosta was the victim of arbitrary detention and as a result lost his life, all framed in a context of violence against the Afro-descendant population in Argentine.
