**Type of pledge:** Single (by one state/actor)  
**Pledging entity:** Brazil

**PLEDGE NUMBER 1:** Civil, political, economic, social and cultural rights: Support and promote initiatives to prevent and confront all forms of violence, prejudice, discrimination and intolerance; combat all forms of violence associated with hate speech and extremism, as well as promote the equitable realization of economic, social and cultural rights, particularly those related to inclusion, justice and social protection and the fight against hunger and poverty.

**Expected deadline within which pledge will be realised:** Dec 31, 2026

**PLEDGE NUMBER 2:** Promotion of social participation, conferences and national plans: Promote and establish continuous and transparent dialogue and effective social control and participation, in line with the strengthening of the National Councils and other national collegiate bodies and the National System of Social Participation, with support for the holding of thematic National Conferences and the inclusive and participatory construction of National Plans on human rights.

**Expected deadline within which pledge will be realised:** Dec 31, 2026

**PLEDGE NUMBER 3:** Racial equality: In the context of the 2030 Agenda, Brazil will have Sustainable Development Goal 18 as an additional target, with a view to achieving racial equality. Effective measures will be taken to promote racial equality, especially within the framework of public policies related to access to education, health, employment and adequate housing.

**Expected deadline within which pledge will be realised:** Dec 31, 2026

**PLEDGE NUMBER 4:** System for monitoring recommendations: Strengthen and improve the commitment to submit periodic reports to the treaty bodies, to participate at a high level and constructively in their examinations and to monitor and implement their recommendations, as well as to support the Universal Periodic Review (UPR) mechanism, the special procedures and the Office of the High Commissioner for Human Rights (OHCHR), through the implementation of a national system for monitoring international human rights recommendations - Simore Brasil Program.

**Expected deadline within which pledge will be realised:** Dec 31, 2026

**PLEDGE NUMBER 5:** Ratifications: Make efforts to advance the ratification process of regional and international human rights instruments, in particular the Inter-American Convention on the Protection of the Human Rights of the Elderly; the Inter-American Convention against All Forms of Discrimination and Intolerance; the International Convention on the Protection of the Rights of Migrant Workers and Members of Their Families; the Optional Protocol on Economic, Social and Cultural Rights; and the Regional Agreement on Access to Information, Public Participation and Access to Justice in Environmental Matters in Latin America and the Caribbean (Escazú Agreement).

**Expected deadline within which pledge will be realised:** Dec 31, 2026
